15th Board Diversity, Independence, and Governance Objectives

1. Board Diversity

To strengthen corporate governance and enhance the structure and development of the Board of Directors, Advantech has adopted the Corporate Governance Best Practice Principles, under which Article 20 specifies that the composition of the Board should consider diversity. In addition to the rule that directors concurrently serving as company executives should not exceed one-third of the Board seats, the Company has formulated appropriate diversity policies based on its operational mode and development needs. These include, but are not limited to, basic attributes and values (such as gender, age, nationality, ethnicity, and culture — with a principle that female directors should comprise no less than 10%), as well as professional knowledge and skills (such as in law, accounting, industry, finance, marketing, or technology), professional background, and industry experience.

2. Diversity of Professional Backgrounds

Considering the diversity of vertical markets covered by Advantech, the professional backgrounds of Board members are expected to closely align with Advantech's business domains and the GICS (Global Industry Classification Standard). A summary is provided as follows:

3. Governance Objectives

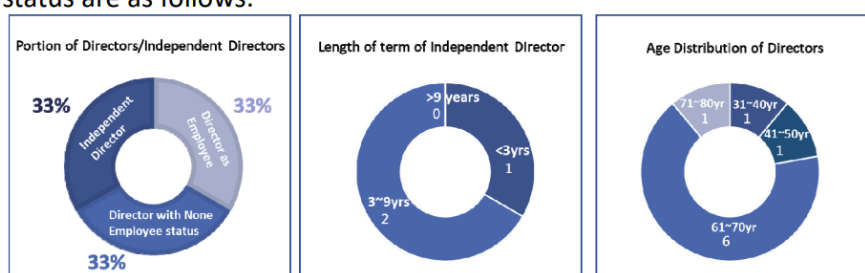
The Board of Directors is responsible for guiding corporate strategy, supervising management, and being accountable to both the Company and shareholders. The governance framework ensures the Board exercises its duties in accordance with legal requirements, the Articles of Incorporation, and resolutions of the Shareholders' Meeting. All Board members possess the necessary knowledge, skills, character, and industry decision-making capabilities. Advantech also continuously offers diversified training programs to Board members to enhance decision-making quality and supervisory function, thereby strengthening Board performance.

The 15th Board of Directors consists of **nine members**, of which **three are Independent Directors (33%)**. In line with the gender balance principle, the 15th

Board includes **one female director (11%)**, exceeding the minimum requirement specified in the **Corporate Governance Best Practice Principles**. Advantech will continue to enhance this aspect in the future.

All members of the Board are local experts from academia and industry, with strong personal insights, global market perspectives, academic and professional expertise, corporate governance experience, and risk management capabilities. They have made significant contributions to the optimization of Advantech's management and achieved the Company's board diversity governance objectives.
