[Figure 2:Self-assessment by individual Directors]








Evaluation Results (Figures 3-5):

- Audit Committee Performance: 8.86 out of 10
- **Remuneration Committee Performance:** 8.88 out of 10
- Sustainable Development Committee Performance: 8.2 out of 10
- The overall evaluation results are excellent. However, the Sustainable Development Committee, which was voluntarily established by the Board and has been operating for only one year, has room for improvement in its operational mechanisms.
- Future improvement plans include director training programs and customized suggestions, succession plans for directors and senior managers, and enhancing the composition and independence of the Sustainable Development Committee. The company will continue to advance these improvement plans to achieve the goal of sustainable operations.

[Figure 5: Self-assessment of the Sustainable Development Committee (SDC)]


