- 2. Strengthen sustainability governance authority: Conduct semi-annual meetings across large-scale boards of directors to enhance talent development and succession rotation, promote comprehensive evolution of corporate development functions, and optimize financial and accounting functions to drive long-term change. Also establish a sustainable development committee at the board level to enhance sustainable governance, deeply discuss long-term strategies, and accelerate the promotion of ESG sustainability strategies.
- 3. Launch corporate inheritance and co-creation and co-governance plan: Based on the premise of maximizing the interests of the company and shareholders, adopt a "professional manager system" as the basis, implement a growth mindset that emphasizes both internal and external factors, and deploy a phased plan that transitions from the "founder era" to the "co-governance era" where ownership and management are separated. Lead the team to embrace new IoT opportunities with the spirit of "co-creation" and "co-governance."

It is vigorously developing the application of sustainable intelligence in various scenarios, especially with smart energy management systems as an emerging market. Advantech is combining its own business with that of its partners to jointly reduce carbon emissions.

- 2. Continuously move towards SBTI goals and climate change response:
- A. In 2022, the unit revenue greenhouse gas emissions of the Taiwan and Kunshan factories decreased by 12.2% compared to 2021, and the unit revenue greenhouse gas emissions of the entire company decreased by 13.1%. Carbon reduction achievement exceeded the original target of 6%-7%.
- B. In 2022, Advantech received a B-level rating in the CDP climate change questionnaire competition and plans to continue to improve its performance in the coming year.
- C. Completed the assessment of Task Force on Climate-Related Financial Disclosures (TCFD) risks and opportunities and quantitative data reporting.
- D. Launched and completed the ISO 14064 greenhouse gas scope 3 full category inventory and verification program, and plans to disclose data in June 2023.
- E. Launched the certification plans for ISO 50001 and ISO 14067, and plans to obtain certification and the first product carbon footprint certification in May 2023.

 Advantech will gradually establish internal methodology and complete the representative product carbon footprint inventory to develop a low-carbon product selection mechanism and achieve long-term green product development goals.

IoT career exploration: Elite 100 IoT internship program In 2022, a total of 35 students in Taiwan participated in the summer internship, producing 14 project proposals, and 7 students obtained extended internship contracts after the summer. In China, 12 interns participated in the program, and 10 students were hired after graduation.
 - B. InnoWorks Developer Program Competition: AloT InnoWorks is an IoT project competition for students and developers worldwide. Based on the Advantech WISE-IoTSuite IoT cloud platform, participants learn about innovative industrial IoT applications in various industries and fields, solve social and environmental challenges, and receive substantial prizes. The themes cover public health, solar and wind energy, smart agriculture, smart factories, smart campuses, and smart cities. In 2022, 90 student teams from 6 countries with over 360 participants joined the competition.

- C. IoT online learning platform [AloT Academy IoT Higher Education Courses and Certifications]: In total, over 800 technical certifications were issued through campus partnerships in 2021-2022.
- 2. Sustainable innovation education and cultural support: The Advantech Cultural and Educational Foundation has long supported sustainable and innovative education, hoping to provide better learning experiences and benefits for Taiwanese children and youth. Through various projects, the foundation is committed to cultivating future talent in areas such as:
 - A. ACT Dreamer: Implemented the PBL model, with the main spirit of the ACT Dreamer program being "to cultivate sustainability awareness for children through creativity and collaboration for deep learning."
